

SUBURBAN WATER, INC.

APPLICATION FOR INSTALLATION OF A NEW RESIDENTIAL WATER SERVICE AND WATER USERS' AGREEMENT

The undersigned Applicant, builder, hereby requests to be supplied with drinking water service to a new residence under construction for the purpose shown hereon, and none other. If this Application is approved and water service is made available by SUBURBAN WATER, the Applicant agrees to the following terms and conditions:

1. Applicant agrees to purchase one meter (5/8-inch size) for a new residential water service at the unit price of **\$6,500.00**. Applicant agrees to pay a minimum monthly charge for water service from the time service is made available and pay for the quantity of water used at the rates set forth in SUBURBAN WATER'S current Rate Schedule. Payments shall be made to the office of SUBURBAN WATER within 10 days of the billing date or prior to the transfer of the water service to the occupant of the residence. Failure of SUBURBAN WATER to issue a service bill shall not excuse the Applicant's obligation to pay for the water used when the bill is rendered. Upon termination of this AGREEMENT and the Applicant's failure to pay the final bill within 10 days of the billing date will result in additional charges (late fee of 2% of the unpaid balance for each billing cycle; shut-off/collection fee of \$8.00; re-connection fee of \$15.00). New water services will not be sold to Applicants/Companies with an unpaid balance with SUBURBAN WATER.
2. Applicant agrees to comply with the laws of the State of Kansas, the By-Laws of SUBURBAN WATER, INC., and SUBURBAN WATER'S Rules and Regulations, as presently exist, and as may be amended from time to time, which are made a part of this Agreement, as though fully set out herein.
3. Applicant agrees to claim no damage on account of the temporary stoppage of the flow of water or reduced pressure resulting from accidents, or when necessary for SUBURBAN WATER to make alterations, repairs, or improvements to the water system.
4. Applicant agrees to keep all components of the plumbing system at the residence in good working condition and shall promptly eliminate all leaks.
5. Applicant agrees that the water service supplied by SUBURBAN WATER shall be for only the sole use of the Applicant and occupants of the residence.
6. Applicant agrees not to extend or permit the extension of pipes for the purpose of transferring water from one structure or property to another.
7. Applicant agrees to not share, re-sell, or sub-meter water to any other structure or location.
8. Applicant agrees that each service meter shall supply water to only one residence located on land within SUBURBAN WATER'S designated service area.
9. Failure to comply with all of SUBURBAN WATER'S Rules and Regulations will result in the removal of the water meter and discontinuance of the water service. Re-installation of the meter, thereafter, shall result in a \$250.00 service charge/violation fee.
10. Applicant agrees that if after water service is made available, the same is discontinued or disconnected for any reason, re-connection shall be upon the conditions established by SUBURBAN WATER.

11. Applicant agrees not to make any physical connection between a private water system and SUBURBAN WATER'S system. Representatives of SUBURBAN WATER may, at any reasonable time, come on the premises where the water is being used for the purpose of conducting an inspection to insure compliance with this provision. Violation of this provision will result in disconnection of this water service.
12. Applicant agrees that the tapping saddle, corporation-stop, piping from the distribution main to the meter-setter, meter, meter-setter, meter vault, and meter cover/lid (collectively known as the service connection), are and shall remain, at all times the property of SUBURBAN WATER. The service connection or any component thereof may be removed by SUBURBAN WATER without notice upon discontinuation of service for any reason.
13. Applicant agrees that the cost for installation for the new water service shall be the responsibility of the applicant. The applicant shall be responsible for all labor and material costs associated with the installation of the new water service, except for those materials listed in condition 14 and those services listed in condition 15.
14. Applicant agrees that SUBURBAN WATER will furnish only the following materials for the new water service: 5/8"x3/4" Water Meter with antenna; 5/8"x 3/4" x 1" Meter-Setter; Meter Cover/Lid; Meter Vault; Tapping Saddle; and Corporation Stop,
15. Applicant agrees that SUBURBAN WATER will furnish only the following services for the new water service: tapping of the water main; and inspection of the completed meter service connection and piping to the structure.
16. Applicant agrees that the cost allocation for the new residential water service is divided into two categories: (1) estimated cost of materials and services provided by SUBURBAN WATER (refer to conditions 14 & 15) is \$3,000.00; and (2) cost allocated to System Development is \$3,500.00 for a total cost of **\$6,500.00**.
